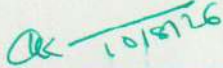

- ❖ Child labour should not be engaged.
- ❖ If anyone suffering from fever, cold, cough and difficulty in breathing, it should be informed to the local health authority,
- ❖ Unnecessary containers or things should be disposed to frequently to avoid mosquito breeding for the prevention and control of vector borne diseases.
- ❖ The number of urinals/toilets should be increased according to staff 's strength.
- ❖ The certificate is valid for one year from the date of issue.
